Because Boughton is classified as a Secondary Service village, despite the extremely limited services, amenities and employment opportunities it offers. I would suggest that Boughton is reclassified as an "other" village, so ensure that it is protected in the same way as other small villages in the district, rather than being held in the same regard as West Haddon, Braunston and Byfield, which are all significantly larger settlements with more local services, amenities and employment opportunities, and which are therefore more able to offer suitable development opportunities, and support further development.
