The village confines map for Badby as shown in the Local Plan conflicts with the village confines as shown in the submitted Badby Parish Neighbourhood Plan. The submitted Badby Parish Neighbourhood Plan village confines exclude two areas peripheral to the village, namely Nene Side to the north and the houses at the top of Bunkers Hill to the south-west of the village. Please see 8.3 Policies map – Badby Village Insert in the submitted Badby Parish Neighbourhood Plan document P46. Objections to the village confines as shown in the Local Plan were provided by Badby Parish Council as part of its response to the Emerging Draft Local Plan consultation and can be referred to there as they have not changed – see P97 of consultation responses document.

Furthermore the Badby Parish Neighbourhood Plan defined village confines have now been confirmed by the examiner's report. The Local Plan quotes the Neighbourhood Planning Act 2017 as stating that the Council should 'have regard to confines in post-examination neighbourhood development plans' for assessing planning applications (see 5.2.26) .
